#### • IMPORTANT Note About Course Outline/Schedule:

This course is scheduled as a fully online and asynchronous course. The course breakdown will be as follows:

- 1) Unless otherwise noted in the weekly breakdown, I will post two lectures each week that total no more than 2.4 hrs of lecture time. These lectures will be posted at 12 PM on Monday and Wednesday each week (unless an exam week). Once the lecture has been posted, you will have 10 days to watch the lecture. After that 10-day period, the lecture file will no longer be available for viewing.
- 2) Each lecture will be accompanied by a reading to be completed before watching the course lecture. After completing the assigned reading and before watching the lecture, you will be required to complete a short Reading Quiz (quiz descriptions and date breakdowns are explained below).
- 3) Each week, after watching the 2 course lectures, you will be required to complete a Lecture Quiz based only on that week's lectures (quiz descriptions and date breakdowns are explained below).
- 4) Each week you will be required to complete 1 discussion post and 1 response to another student's discussion post. These discussion posts are explained in detail below.

## • Evaluation/Homework Assignments:

- **1. Quizzes:** As outlined on the weekly course breakdown below, there will be <u>two</u> types of guizzes in this class.
  - (1) Reading Quizzes: Prior to each new section lecture/new topic/new reading, there will be a quiz to be completed prior to the lecture on that reading/subject (see weekly breakdown below for details). These quizzes must be completed in CANVAS and must be completed prior to watching the associated course lecture video. Each Reading Quiz will be made available on the date stated in the weekly breakdown and will be available until Friday each week, I suggest that you do not wait to complete the quizzes until Friday stay on top of the work each week). These quizzes will be multiple choice and/or true and false. Each quiz will be worth 10 points. Once you begin a quiz, you will have 20 minutes to complete it. Please Note: Once you

answer a question, you will not be able to go back and change your answer.

(2) **Lecture Quizzes**: As illustrated in the weekly breakdown below, each "class session" will involve a lecture/video assignment on the material assigned for that class. At the end of each week (on Friday each week) students will be required to complete a *short* quiz on the lecture material provided *that week*. This quiz will be available in CANVAS on Friday by 11:59 PM and must be completed no later than 12 PM Monday. Once you begin a quiz, you will have 20 minutes to complete it. **Once you answer a question, you will not be able to go back and change your answer.** Like each Reading Quiz, the Lecture Quizzes will be multiple choice and/or true and false. Each Lecture quiz will be worth 10 Points.

## **IMPORTANT Quiz Notes:**

- 1) There will be no make-up quizzes if you miss a quiz (any type). It is your responsibility to review the *Due Each Week Summary* on the Weekly Breakdown (below). Please Note (again): Late work for good cause such as medical or family emergencies (including COVID-19 related reasons like illness or quarantine) may be excused on a case-by case basis, typically with advance written notice and appropriate documentation.
- 2) To do well on these quizzes and thus to do well in the class, you should make sure to watch each class lecture video in a timely manner, to complete all the assigned readings, and to review your lecture notes. Reading Quizzes will NOT be based on Weekly Case Study Readings.
- 3) The quiz breakdown can be a little confusing at first. If you are confused in any way about the detailed quiz schedule, it is <u>your responsibility</u> to come and speak to me during my office hours. Not understanding the schedule will not be grounds for a make-up.
- 4) If you have any issues during the quiz (like, for example, a system freeze) please email me or *preferably* speak to me during my office hours.
- 5) At the end of the term, I will drop the lowest score on each type of Quiz.
- 2. Discussion Posts: Each week you will be required to complete 1 discussion post concerning the materials due that week. In addition, you will be required to respond to 1 discussion post posted by one of your fellow students each week. There are 45 students in the class. To keep your reading workload at a reasonable level, each week you will be automatically placed in a randomly generated, small group of students (around 8). You are only responsible for reading/posting in your group (meaning, you do not need to read 38 weekly discussion posts in order to complete your discussion post response. Each posting will be worth 2.5 points (equaling 5 total points each week). These points add up. Missing one posting will not impact your final grade in the class, but missing multiple postings will impact your final grade. There are no make-ups on missed postings. Discussion Posts and Replies are due each week by 11:59 PM

on Friday. There will be no discussion posts due the week of the Midterm Exam & Final Exam.

For each assignment, you will be provided with assignment topics, structural details, and a grading rubric two weeks prior to the due date for each essay. Assignments must be submitted by the date and time specified on the prompt. No emailed essays will be accepted. All essays will be submitted as a PDF file in CANVAS.
